Release and Hold Harmless Agreement & Safety Guidelines for Use of Club Boats

As a participant in the North Shore Yacht Club's boating program, I recognize and acknowledge that there are certain risks of injury. I agree to assume the full risk of any injuries, damages, or losses of any type whatsoever, which may be sustained as a result of participating in the North Shore Yacht Club or any activities connected to or associated with the boating program or North Shore Yacht Club.

- I agree to waive and relinquish all claims I may have against the North Shore Yacht Club, its officers, directors, agents, servants, and employees as a result of participating in the North Shore Yacht Club or its boating program.
- I hereby fully release and discharge the North Shore Yacht Club, its officers, directors, agents, servants, and employees from any claims from injuries, damages, or losses which may sustain as a result of participating in any activities connected to or associated with the North Shore Yacht Club or its boating program.

- I further agree to indemnify and hold harmless, and defend the North Shore Yacht Club, its officers, directors, agents, servants, and employees from any claims resulting from injuries, damages, or losses sustained by me or my family from my participation in the North Shore Yacht Club or club-sponsored events.
- I agree to adhere to the mandatory safety guidelines for use of club boats adopted from time to time by the NSYC . The full guidelines, including additional guidelines applicable to sailors 16 years old and younger, can be found on the website, posted at the NSYC Park Ave Facility or may be obtained from any Club officer. The current guidelines include the following:
 1. All members must be certified by NSYC sailing instructors prior to using the club sailboats and a designated NSYC officer prior to using the club kayaks.
 2. No club boat may be used alone. We require at least two boats to be on the water and sailing/paddling together at all times within hailing distance using the “buddy system”.
 3. All people on the boat must wear properly fitted and fastened US Coast Guard Approved Type III Personal Floatation Devices at all times while using the boat (from shore to shore).
 4. Club boats may not be used in heavy surf or high wind conditions or when lightning is occurring or likely to occur.
 5. Club boats are for the exclusive use of club members (although a limited guest temporary membership can be obtained.)
 6. Members who use the club boats are responsible for any damage they incur to the boat or other equipment.
 7. When feasible, notify the Park District staff of your boating departure and the time you will return.

I have read and fully understand the above Release and Hold Harmless agreement. In addition I/we acknowledge that violation of Club boating safety guidelines or Club bylaws may lead to termination of membership depending upon the severity and details of the situation..
